DIRECT TAX DISPUTES

Revised limit to be applicable to pending cases as well: CBDT

FE BUREAU New Delhi, August 21

IN A BID to remove any ambiguity over the withdrawal of direct tax-related litigation, the Central Board of Direct Taxes (CBDT) on Wednesday clarified that the revised higher threshold for filing appeals would be applicable to

all pending cases as well.

The Board directed the income tax department to withdraw all such pending cases where claim amounts fall below the revised limit from different appellant forums by October 31.

Just a year after the CBDT had raised the monetary limit of claims for the income tax department to file appeals in higher judicial forums, the board on August 8 again



raised the threshold 'as a step towards further management of litigation'. The threshold now stands at ₹50 lakh for appeals before the appellate tribunal in income tax matters. Similarly, it has been raised to ₹1 crore for appeals before the high courts and ₹2 crore for

The CBDT has rightly provided the clarification in light of the recent litigation on this subject. The express instruction to withdraw cases in a time-bound manner comes as a welcome relief."

Last year, the board had raised the monetary limit for appeal in tribunal to ₹20 lakh from ₹10 lakh. The threshold was more than doubled in case of appeals before the high courts to ₹50 lakh from ₹20 lakh. For appeals before the apex court, the limit had been raised four folds to ₹1

The board hasn't provided information on the reduction of cases due to higher threshold. After the last year's increase, it had said the income tax department would withdraw 34% of cases stuck in the appellate tribunal, 48% of those stuck in high courts and 54% in the Supreme Court. The department has struggled to attain any significant progress in concluding disputes to recover tax de-

According to Budget documents, over ₹6 lakh crore was stuck in litigation at the end of FY18.

The recent CAG report said: "The arrears of demand increased from ₹10.4 lakh crore in FY 2016-17 to ₹11.1 lakh crore in FY 2017-18. The department indicated that more than 98.2% of uncollected demand would be difficult to recover.

Centre for greater discom role to promote rooftop solar

TO PROMOTE ROOFTOP solar (RTS) across the country, the ministry of new and renewable energy (MNRE) has directed state-owned power distribution companies (discoms) to be more proactive in achieving the government's

In its latest guidelines for the second phase of the grid connected rooftop programme, the MNRE said that discoms would be "at forefront as key drivers for rapid deployment of RTS" and these entities "should create customer friendly environment by making enabling provisions in their regulations and smooth approval process required for RTS."

The government, in February, had approved the second phase of the "grid connected rooftop and small solar power plants programme" for achieving cumulative capacity of 40 GW rooftop capacity by 2022. The first phase of the rooftop



solar program, which aimed to add 4,200 MW of such capacity by FY20, has not shown much promise with the current installed rooftop solar capacity standing at around 1,709 MW only.

As FE reported earlier, discoms'apathetic approach coupled with the lack of appropriate financing options available in the market are seen to be impeding the uptake of rooftop solar in the country. Discoms tend to see rooftop solar primarily as a threat, fearing that it would lead to them losing paying clients.

Rooftop solar suppliers often complain about discoms in several states deliberately havcomplex approval processes for solar rooftops.

'It's a good initiative on part of government to make discoms responsible for rooftop solar capacity addition," said Shravan Sampath, CEO, Oakridge Energy which is a rooftop solar installer. "However, removing central financial assistance for institutions (schools, colleges and NGOs) is a bit premature in our opinion, as a lot of capacity addition can be achieved in this area."

The latest phase of the RTS program provides central financial assistance (CFA) of up to 40% of the benchmark cost for installation of rooftop solar up to 3 kW capacity and at 20% of benchmark cost for plant capacity from 3kWp to 10 kWp for residential sector consumers only. Further, the program also provides CFA upto 20 % of benchmark cost for group housing societies and resident welfare associations for supply of power to common facilities. While ₹6,600 crore had been earmarked towards CFA for residential sector, ₹4,950 crore was designated as

"incentives to discoms". On Wednesday, power minister RK Singh launched the 'state rooftop solar attractiveness index' which, the minister said, "would incentivise rooftop solar by creating healthy competition among the states". Karnataka ranks first in the index that evaluates states based on their attractiveness for rooftop development.

New vehicle test facility, engineering courses add to upcoming EV ecosystem

AS AUTOMOTIVE OEM companies take calibrated steps towards electric-mobility, the ecosystem around them is getting ready for e-mobility. From industry research bodies to engineering colleges and academia, all stakeholders seem to be working out plans to prepare for

the electrification journey. The Automotive Research Association of India (ARAI) has been working on setting up a Centre of Excellence for e-mobility in Pune to offer facilities for developing, testing, validating and certification of electric vehicles, systems and components for electric vehicles.

KC Vora, senior deputy director of ARAI and ARAI Academy, said these labs would be operational from October.

Companies are working on their electric vehicles and it takes around a year to test and validate a vehicle, he said, adding that ARAI has already started certifying electric vehicles.

A first-of-its-kind academic programme has also been launched in Pune to train engineers in e-mobility with industry and academia joining hands to nurture the much-needed talent. Three academic institutes are starting post-graduate diploma programme in electric mobility in association with the Mahratta Chamber of Commerce, Indus-

tries and Agriculture (MCCIA). The College of Engineering, Pune (CoEP), Cummins College of Engineering for Women, Pune and Savitribai Phule Pune University (SPPU) have launched the programme partnering with ARAI and automotive industry players Bajaj Auto, Kinetic Green, KPIT, Tata Motors and Tata Auto-

comp Systems have chipped in. The MCCIA has taken the lead in creating this programme and bringing both industry and academia together while the institutes will deliver the programmes. The

with the industry. Bharatkumar Ahuja, director CoEP, said there is a need for trained manpower and the course is tailor-made to meet the industry needs.

Vishwanath Rao, MD of Altair, said his company would provided students the latest simulation tools that the industry uses. Altair has close to 1,000 customers in India across the automobile industry value chain that use their tools for designing, engineering and validation of their products and understands the methodology the industry uses and they

also have a consulting practice working with companies on designing motors, reducing weight, aerodynamics and design.

Pradeeep Bhargava, president MCCIA, said the course was the result of collaboration between industry and the academia. The electric mobility revolution is expected in the country but the lack of skilled manpower for the sector was a problem so in consultation with the COEP, Cummins College of Engineering and the SSPU this course was finalised.

Better.com raises \$160 m

PRESS TRUST OF INDIA New Delhi, August 21

BETTER.COM, AN online mortgage platform in the US, on Wednesday said it has closed a \$160-million (about ₹1,144 crore) funding round from Activant Capital, Ping An Global Voyager Fund and Ally Financial among others.

The Series C round also saw participation from Citi, AGNC, Healthcare of Ontario Pension Plan (HOOPP) and American Express Ventures, who joined existing shareholders Goldman Sachs, Pine Brook, and Kleiner Perkins in the round, a statement said. "The capital we've raised will enable us to accelerate our investment in product development, grow our strategic partnerships, expand our team and scale our platform to continue making it easier for borrowers to get home financing," Better.com CEO and founder Vishal Garg said.

Better.com said it has grown 3X year-on-year and is currently funding \$375 million in mortgages a month in the US, which puts it on track to lend over \$4 billion in 2019.
