Pursuant to the provisions of Section 140(2) of the Companies Act, 2013 and the Rules framed thereunder, we hereby tender our resignation as Statutory Auditor of Solex Energy Limited with effect from August 23, 2025

The reason for our resignation is the increased professional workload and realignment of our internal resources and client portfolio, which makes it difficult for us to allocate adequate time and resources to meet the high standards of audit quality and timelines required for your Company as a listed entity. In order to avoid any disruption to the audit process and in the interest of good corporate governance, we believe it is appropriate to step down at this stage.

We have completed Statutory Audit in respect of Financial Statements for the year ended 31/03/2025 and issued our Audit Reports related to the Audit of Standalone and Consolidated Financial Statements on 12/05/2025, Our resignation will be effective from closing business hours of August 23, 2025.

We further agree to provide all necessary assistance, clarification and information as may be required by the Company including Without limitation, the information required in accordance. With circular issued by the Securities and Exchange Board of India bearing number CIR/CFD/CMPIN 44 2019 dated October 18, 2019.
